WHEREAS, Govt. College of Teacher Education, Samastipur, Plot No. 1560, 1556P, Street No. Ameerganj, Vill-Dharampur, Po-Samastipur, Tehsil/Taluka-Jitwarpur, Town/City-Samastipur, Dist. Samastipur, Bihar-848101 was granted recognition for B.Ed. Course with an annual intake of 100 vide ERC Order No.23237 dated 17.01.2014 from the academic session 2014-2015, followed by revised recognition order vide No.32088 dt.25.05.2015 with an annual intake of 100 (Two Basic Units) from the academic session 2015-2016 as per NCTE Regulations, 2014.

- 2. **AND WHEREAS**, as per decision of the ERC taken in its 273rd meeting held on 14th June, 2019, withdrawal order vide No.60916 dt.27.06.2019 issued to the institution from the academic session 2020-2021.
- 3. **AND WHEREAS**, the institution preferred appeal and the Appellate Authority vide order No.89-265/ E-170729/ 2020 Appeal/ 1st Mtg.-2021/ 18th January, 2021/ 97010dated 28.01.2021 remanded back the case to the ERC with a direction to consider the approved faculty list, to be submitted to them by the appellant, and take further necessary action as per NCTE Regulation, 2014. The appellant is directed to forward to the ERC the approved faculty list within 15 days of receipts of orders on the appeal.
- 4. **AND WHEREAS**, Institution submitted its representation dt.29.01.2021 received in this office on 04.02.2021 and some more additional documents through E-mail on 15.02.2021. The ERC in its 290th meeting held on 03rd March, 2021 considered the original file alongwith other related documents, NCTE Act, 1993, Regulations and Guidelines issued by NCTE from time to time and appeal order dated 28.01.2021 were carefully considered by ERC and the Committee decided as under:-

Restoration of recognition order of B.Ed. course with an annual intake of 100 (two units) be issued.

- 5. NOW THEREFORE, withdrawal order dated 27.06.2019 issued to the institution viz. Govt. College of Teacher Education, Samastipur, Plot No. 1560, 1556P, Street No. Ameerganj, Vill-Dharampur, Po-Samastipur, Tehsil/Taluka-Jitwarpur, Town/City-Samastipur, Dist. Samastipur, Bihar-848101 for B.Ed. course is hereby restored permitting the total annual intake of 100 (two basic units).
- 6. The terms and conditions of the revised recognition order No.32088 dt.25.05.2015 issued to the institution shall remain unchanged.
